Annual Policy Catalog & Roadmap Process

Policy Initiatives Catalog

- ISO accepts policy initiative proposals from stakeholders and documents stakeholder support for proposed initiatives
- Catalog reflects shared priorities of ISO stakeholders and Regional Issues Forum (RIF)
- Input to the Policy Roadmap prioritization process

Policy Initiatives Roadmap

- Work plan that describes the policy initiatives the ISO will undertake over the next 3 years
- Final Roadmap represents intersection of stakeholder-identified priorities from the Catalog, [ISO Critical & Strategic objectives](#), initiative feasibility, urgency, and ISO resources.
- Includes initiatives identified by both stakeholders and the ISO

Policy Catalog and Roadmap Objectives

- **Meaningfully engage external stakeholders**
 - Stakeholders propose and advocate for their own initiatives
 - Final catalog includes stakeholder prioritization
- **Transparent**
 - Clear methods to identify and prioritize proposals
 - Open and transparent access to all stakeholders to influence policy enhancements roadmap
- **Allows stakeholder prioritization to be considered in the ISO's internal planning processes, together with:**
 - Alignment with ISO strategic goals and already planned work
 - Project impact on market efficiency and system reliability
 - Implementation cost
 - Other ISO commitments

 - Issue description
 - Initiative description
 - Market impact
 - Timing/urgency
 - Data availability/needs

Catalog: stakeholder-led prioritization process

Stakeholder Working Groups

- Develop understanding of breadth of stakeholder support for individual submissions & reasons for support
- Identify logical groupings of submissions
- Clarify purpose of submissions

Regional Issues Forum Roundtable

- RIF sector liaisons compile feedback from members about themes, issues, and priorities; synthesize common priorities among sectors.
- WEM Regional Issues Forum: [April 9, 2025](#), PacifiCorp, 825 NE Multnomah St, Portland, OR

Prioritization Ranking Survey

- All stakeholders invited to nominate individual initiatives and categories of initiatives as top priorities, and rank remaining initiatives as support/neutral/oppose

Categorizing Potential Submissions

1. **Discretionary market design initiatives** – candidates for the Catalog
2. **Non-discretionary initiatives** (e.g. FERC Orders)
3. **Issues being addressed** in current initiatives / working groups
4. **Transmission and Infrastructure Planning**
5. **Process improvements**

Process change for 2025: Submissions that are **not** discretionary market design initiatives will be directed to the relevant ISO process for prioritization

Infrastructure-related policy suggestions will be considered in existing, recurring policy initiatives.

- The ISO will consider new infrastructure-related policy concepts in the 2025-2026 Transmission Planning Process (TPP) or the next (2025-2026) Interconnection Process Enhancements (IPE) initiative.
 - If neither the TPP nor IPE initiatives are appropriate venues for certain policy recommendations, the ISO will consider a new stakeholder initiative.

Process Improvements & Enhancements

Enhancements are assessed based on their level of impact to the broader market and feasibility from a technical perspective. This review helps drive the appropriate level of prioritization against the “Big Picture” of current efforts in flight and their associated business drivers.

Updates are typically provided when an enhancement is being delivered depending on its overall external visibility in the Release User Group, Technical User Group, and potentially Market Simulation Forums.

New Enhancement Tool

- The ISO recognizes the opportunity to maximize transparency of enhancement requests. We are still in the developmental stage of an enhancement tool that will provide greater visibility not only our Market Participants, but to our broader group that includes our direct customers, regulatory bodies, government agencies, associations, advocacy groups, and the general public.
- The new enhancement tool is separate from our CIDI application
- Some of the request data will be visible for all parties to view to ensure transparency and to increase efficiencies (avoid duplication)
 - No user account / passwords needed
 - No certificate, access or privileges needed
- Further updates on this tool once ready will be provided by end of Q2 2025.

Enhancement Requests – Scheduling Coordinators

- Enhancement requests to existing processes or tools can be made by Scheduling Coordinators via the following process:
- Submit a CIDI ticket with the following information:
 - Subject Line: “Enhancement Request”
 - Description:
 - Application: Application Name/Process
 - What: provide a detailed description of the request
 - Why: explain purpose of request (reason it is needed)
 - Who: who benefits from this enhancement - including level of impact to you organization
 - Reliability impact?

Enhancement Requests – Other Market Participants

- Enhancement requests to existing processes or tools can be made via the following process:
- Submit a Contact Us case via caiso.com with the following information:
 - Subject Line: “Enhancement Request”
 - Description:
 - Your Organization
 - Application: Application Name/Process
 - What: provide a detailed description of the request
 - Why: explain purpose of request (reason it is needed)
 - Who: who benefits from this enhancement - including level of impact to you organization
 - Reliability impact?

Catalog & Roadmap Schedule: Next Steps

- **January 30:** Catalog submissions template posted
- **January 30 - February 28:** ISO accepting Catalog submissions for new discretionary market design policy initiatives from all stakeholders
- **March & April:** Stakeholder prioritization workshops for Catalog submissions
 - Clarify purpose of submissions
 - Develop understanding of breadth of stakeholder support for individual submissions
 - Identify logical groupings of submissions
- **May:** Stakeholders submit prioritization rankings
