- Be responsive to stakeholder desire to continue Demand and DER market participation model and policy design discussions through a stakeholderdriven process;
- Promote shared understanding of current market participation options for demand and distributed energy resources; and

Review of Working Group Model

Working Group Structure - Roles

- Facilitator: the Working Group will be managed by a designated ISO facilitator.
 - Responsible for guiding discussion on principles, problem statements, and prioritization.
- Scribe: the Working Group has a designated scribe.
 - Responsible for capturing discussion and evolution or proposal(s), publishing meeting summaries, and working jointly with the facilitator.
- Subject Matter Experts: provide their in-depth knowledge and expertise in a specific sector or
 policy to deliver accurate and up-to-date information, and advice on working group deliverable
 development.
 - Responsible for development of market policies and procedures relevant to their area of expertise
- Working Group Participants: provide ideas, proposals, input, and vetting.
 - Working groups are open to all stakeholders.
 - ISO staff will also be participants in working group.



Working Group Deliverables

Demand and Distributed Energy Market Integration: Initial scoping discussions for this Working Group will be captured in a discussion paper, which will be iteratively updated as the Working Group progresses to reflect Stakeholder discussion.

The Discussion Paper will take an iterative approach, creating a history and providing opportunities to reflect, comment, and prepare for subsequent discussion.

Stakeholders will have opportunity to provide comments on the Discussion Paper during meetings, as well as written comments via the commenting tool.





Demand and Distributed Energy Market Integration Working Group Goals

Stakeholders have the opportunity to provide input on key components leading up to proposal development, ahead of the policy development phase:

1. Develop Principles:

Define and illustrate principles for market design

2. Form Problem Statements:

Form problem statements reflecting stakeholder concerns

3. Align on priorities and establish meeting cadence

Balance staff and stakeholder bandwidth

4. Justify problem statements:

- Explore current ISO market operations, functionality, processes meant to address problem statements
- Develop methodology for analysis, define data needs

5. Determine Action Items

Provide a bridge between working groups and proposal development



Action items articulate the stakeholder vision

- Action items might include interim steps to facilitate consensus and derive more value from an initiative, for example:
 - A commitment to a second phase of working groups to address lower priority topics and concepts without straining stakeholder bandwidth
 - A request for ISO staff to provide data analysis or assessments of operational feasibility
 - A proposal for evaluation or coordination of topics deemed outside of the ISO's jurisdiction



Context: the final 2024 CAISO Policy Initiatives Roadmap indicates this working group as the venue to discuss various catalog items

Working Group Scoping

Demand and Distributed Energy Market Integration Working group principles

The following principles reflect standard principles of market design, and should be kept in mind when moving through the working group process (**note**: Not every topic will align with all principles listed; the principles are a resource to facilitate assessment of prioritization and potential trade-offs associated with problem statements):

1. Efficiency

 Market co-optimization processes utilization of demand and distributed energy resources produces least cost market results while meeting reliability needs

2. Competition

 Market rules expand competition to the benefit of consumers and allow flexible demand and smaller scale resources to participate in a similar manner as conventional, large-scale generators



Proposed Working Group Principles (cont'd)

3. Feasibility

- Operationally feasible; the market can solve within prescribed timelines
- Feasible implementation

4. Simplicity

Market design elements are not overly complicated

5. Reliability/Compliance

Reliability and compliance standards are reflected in market design

6. Jurisdictional roles and responsibilities

Market design should facilitate state public policies, to the extent practicable
